

AREAS OF ACTIVITY

Ristuccia Tufarelli & Partners has many years of experience in the main branches of law as well as in particular areas such as securities markets law, public procurement, telecommunications and information technology, privacy and e-government processes.

Banking and Finance

In these sectors, the Firm mainly deals with: corporate disclosure, assistance to banks, Investment Firms (SIMs), asset management companies (SGRs), financial advisors in the field of securities brokerage, admission to listing, asset management, derivative products, establishment of collective investment schemes, administrative and judicial defence in the field of sanctions imposed by the supervisory authorities, actions for damages, contracts, supervisory and regulatory issues; disputes regarding lines of credit, guarantees, bankruptcies, bank contracts, credit instruments; debt restructuring operations; special credit operations; assistance in drawing up anti-money laundering and privacy procedures; leasing; factoring; securitization operations.

launch online activities; implementation of innovative digitisation projects in the public and private sectors; issues related to ICT & IoT systems; institutional relations with the authorities responsible for managing e-government processes in the public and private sectors.

Administrative and regulatory

The Firm has gained a widely recognized experience in the field of public contracts regarding technological and high added value services, assisting companies both in the phase of the procedure and in the settlement of related disputes in court and arbitration. With particular reference to the economic activities supervised and subject to regulation, the Firm gained a particular and ten-year experience in proceedings before Independent Administrative Authorities (such as for example AGCM, AgCom, ANAC and AIFA). Commercial and corporate




